Terms and Conditions

- 1. The Promotion is promoted by LG Electronics U.K. Ltd (the "Promoter").
- 2. The 'How to Claim' instructions form part of these Terms and Conditions. By using and/or benefitting from the Netflix Promotion (the "Promotion"), the participants agree to be bound by these Terms and Conditions.

Participants must purchase a qualifying LG OLED or Super UHD or UHD SMART TV ("Qualifying Product") from any participating retailer between 08:00 GMT+1 Wednesday 16th August 2017 and 23:59 GMT+1 on Tuesday 10th October 2017 to be able to participate in the Promotion.
