



## Canon (UK) Point-based School Incentive - Terms & Conditions

### 1. PROMOTIONAL PRODUCTS, PROMOTIONAL PERIOD AND PROMOTIONAL OVERVIEW

1.1. This incentive is only available on purchases made of any of the products listed below (the “**Promotional Products**”) within the United Kingdom (“**UK**”) or Republic of Ireland (“**ROI**”) from a UK or ROI reseller between **Wednesday 24<sup>th</sup> August 2016** and **Tuesday 28<sup>th</sup> February 2017** inclusive (the “**Promotional Period**”).

1.2. Primary Schools would be able to buy a selected range of Canon products based on the points accumulated by parents and members of the public. Parents and the public would need to buy selected printers, cameras and calculators and they would be able to acquire a certain number of points per product. These points can be given to any school if the individual who bought the product completes a simple claim form. The school would be emailed their login details and, using the required amount of points, they would be able to select and acquire a selected range of Canon products at no cost

1.3. All Participants must be aged 18 or over and must be resident in UK and ROI (“**Participant**”).

1.4. All Participants are deemed to have agreed to be bound by these terms and conditions.

1.5. All products must have been supplied and distributed to retailers by Canon UK Ltd (“Canon”) or Canon group companies located in the European Economic Area or Switzerland (“**EEA**”). Please check with your retailer that this is the case to help avoid disappointment. Internet stores must display a registered/postal address in the UK or ROI.

1.6. All Promotional Products must be new and genuine Canon products. Purchases of second hand, refurbished or reconditioned products, or products which are counterfeit or infringe the intellectual property rights of the Canon group of companies in any way (for example, including but not limited to parallel or “grey” products) will not qualify under this promotion. 1.7. This promotion is only open to public/government-funded primary schools. Privately funded primary schools are excluded from this promotion

### 2. HOW TO PARTICIPATE

2.1. To enter this promotion, the Participant must purchase a Promotional Product from a UK or ROI retailer or reseller during the Promotional Period AND submit a valid claim online.

2.2. The closing date to submit point allocations is midnight on Tuesday 28th February 2017. A one month grace period is in place (ending on Tuesday 28th March 2017) allowing final point allocations to be made by customers from products bought during the promotional period, which is Wednesday 24th August 2016 to Tuesday 28th February 2017.

2.3. 2.4. As soon as the points entered into the online form are verified, an email will be sent to the school informing them of the points they have acquired. Throughout the promotional period an unlimited number of parents/members of the public can offer points to any school in the UK and Ireland. These points can be saved up and used by the school to claim a variety of set Canon products (via an online claim portal). Login details to the claim portal will be sent to the school as soon as the first submission is made by a parent/members of the public.

2.5. Canon's warehouse in the Netherlands will be responsible for distributing the points-bought products to the primary schools. Depending on the product selected, stocks may be limited. Canon and Canon's distributors will not be liable for the failure to fulfil orders.

2.6. Canon will not process any **point-allocation** requests received after **midnight on Tuesday 28th March 2017**. Canon will not process **point-allocation** requests, which are in its opinion incomplete or illegible. Canon will not be responsible for claims delayed or not successfully received.

2.7. Claims by businesses or individuals who make bulk purchases (being more than 10 selected products during the Promotional Period, other than where the relevant products are comprised in kits or bundles as described in clause 1.1) will not be eligible to allocate points to a school.
