

Canon (UK) Winter 2015 Cashback & Prize Draw promotion Terms & Conditions



1. PROMOTIONAL PRODUCTS, PARTICIPATING RETAILERS, PROMOTIONAL PERIOD AND PARTICIPANTS

1.1. This promotion is only available on purchases made of any of the products listed below (the "Promotional Products") within the United Kingdom ("UK") or Republic of Ireland ("ROI") from one of our participating retailers ("Participating Retailers" – for a full list of participating retailers please visit www.canon.co.uk/Wintercashback) between Wednesday 14th October 2015 and Wednesday 13th January 2016 inclusive (the "Promotional Period"). All other products and retailers are excluded. Promotional Products can be sold as a camera body only or part of a lens kit or bundle but only ONE claim can be made per kit or bundle. So if a kit includes two Promotional Products, the Participant will need to pick one product against which to make a claim. Purchases must be genuine purchases for cash or its equivalent.

- 1.2. All Participants must be aged 18 or over and must be resident in UK and ROI ("Participant").
- 1.3. All Participants are deemed to have agreed to be bound by these terms and conditions.
- 1.4. All Promotional Products must be new. Purchases of second hand, refurbished or reconditioned products will not qualify under this promotion.

2. HOW TO PARTICIPATE

- 2.1. To enter the cashback promotion, the Participant must purchase a Promotional Product from a Participating Retailer during the Promotional Period AND submit a valid claim online. 2.2. The closing date to claim cashback is midnight on Saturday 14th February 2016.
- 2.3. When claiming cashback you can also select to have your details entered into the Prize Draw. The closing date for entry into the Prize Draw is Wednesday 13th January 2016.
- 2.4. Claims for the cashback and Prize Draw must be submitted by fully and correctly completing (including specifying a valid EEA product serial number) a claim form online, at www.canon. co.uk/Wintercashback. Canon will not process claims which are in its opinion incomplete or illegible. Canon will not be responsible for claims delayed or not successfully received.

3. CASHBACK
