'Purchaser' means a resident of UK who purchases a Hotpoint dishwasher from a Participating Retailer during the Promotional Period, and is the end user of that Unit 'Promoter' means Whirlpool UK Appliances, Morley Way, Peterborough PE2 9JB. 'Promotional Period' means the period between 04/11/2015 to 24/12//2015 (inclusive).
- 2.
